CEO Message



Last year, the COVID-19 pandemic brought significant change to our society and exposed inequities built into our current systems. Addressing these inequities is an ongoing challenge to which the Foundation is committed. In March 2020, ECF created the COVID-19 Rapid Response Fund. Through the RRF, we granted \$1.9 million—more than half of this to organizations working with marginalized communities.

In the fall of 2020, the light shone on anti-Black and anti-Indigenous racism presented an opportunity to take additional action supporting antiracism initiatives. The Anti-Racism Fund was created specifically to support the works of Black- and Indigenous-led and serving organizations. To date, more than \$800,000 has been granted through the fund. This work also helps ECF engage, empower, and build awareness about these organizations' positive impact in the community. The pandemic has, therefore, seen us engage our equity strategy in our efforts to "build back better."

ECF will continue to respond to Edmonton and area's changing needs and the many people and socio-cultural communities that are part of it. We will strive to support inclusive and equitable organizations. We will increase our work with diverse groups towards shared goals. We will engage diverse voices so that all communities within the Edmonton area see

themselves reflected in the Foundation's work.

If you would like to join us in these efforts, please consider a contribution to either the Rapid Response Fund or the Anti-Racism Fund. More details on these opportunities can be found on our website.

If you do decide to contribute, please remember that to receive a charitable tax receipt for the 2021 year, gifts of cash (or via credit card) need to reach ECF *before* December 31 or, if mailed, bear a postmark of December 31 or earlier.

eCF can also accept gifts of securities or mutual funds, but there are additional processes involved. If you plan a gift of securities as part of your year-end giving, please contact our Donor Services team *before* arranging the transfer. Call **780.426.0015** or **donorservices@ecfoundation.org**. Arrangements for these gifts need to be made *now* and can take longer than one would think. So please don't wait!

Year-end giving - It's never too early to start

Gifts to your fund

December 31 is the final day you on which you can make a charitable gift to claim on your 2021 personal tax return.

Online gifts or gifts mailed with a Canada Post date stamp of 2021 on the envelope can ensure you receive a 2021 donation receipt.

Gifts of securities

If you are considering making a gift-inkind, like publicly traded securities (shares or mutual funds) to your fund at ECF, we ask that you contact us as soon as possible. We will provide you with the most up-to-date transfer forms, along with the information you and

your advisor will need to ensure the transfer is done smoothly.

Gifts of securities will take at least a few days to complete. Gifts of mutual funds generally take longer than gifts of shares. ECF suggests these deadlines to ensure your gift will be processed on time:

- For gifts of mutual funds, no later than December 1.
- For gifts of securities, no later than December 15.

ECF cannot guarantee that transfers initiated beyond these dates will be completed before the end of the year. Many employees are working remotely but are accessible, so if we can be of any assistance or if you would like to discuss a potential gift before the end of the year, please contact
