Through donor support, ECF was able to disburse \$11.0 million in 2012. Here are a few of the organizations ECF helped:

- The Art Gallery of Alberta received \$16,000 to support its Art Express program, which provides art classes to adults with developmental or physical challenges.
- The local chapter of the Multiple Sclerosis Society received \$30,000 to create MSGPS, a pilot project that consolidates resources and information for people diagnosed with the disease.
- Options Sexual Health received \$23,000 to help purchase a new van, which will enable them to reach 5000 to 10,000 youth each summer with materials and information to keep them healthy and safe.
- The Brian Webb Dance Company and The Alberta Ballet received a combined total of \$46,800 to support programs that engage younger audiences and encourage artists to pursue dance as a career.






